- (a) All TETA registered SDF's are required to update their information and upload a certified ID copy, SDF appointment letter (signed by the organisation's executive on the Company letterhead), company details and levy number.
- (b) **New** SDF's will be required to link themselves on TETA online system with relevant levy number and SIC code as per system user guide and upload the information as in (a), access to the system remain pending

until compliance has been verified by TETA. On acceptance, the chamber against which the levy number is registered will approve the SDF for access.
