Transport Education Training Authority (TETA) invites qualifying unemployed learners to apply for bursaries for the 2023 academic year.

## WHO SHOULD APPLY?

- Learners currently in Grade 12 / who have completed matric intending to study qualifications selected for the 2023 intake (see qualification list below);
- Currently registered students at universities and colleges who require funding for the 2023 academic year;
- Aviation students with valid PPL or CPL;
- Commercial divers with matric (Senior Certificate).

Applicants must be studying or intending to study at University (Public/Accredited Private Institutions), University of Technology, Technical and Vocational Education and Training (TVET Colleges: Public/Accredited Private), Accredited Aviation Schools and Accredited Diving Schools.
