RE: ADDENDUM No. 1 – BID NUMBER: TETA21/FIN/0006/INSURANCE

This Addendum shall be read in conjunction with and shall form part of the above-mentioned request for bid (RFB) document, **BID NUMBER: TETA21/FIN/0006/INSURANCE**.

In light of the queries raised and difficulties experienced by bidders, the RFB document is therefore amended as follows:

 - 1.1.2. Legal Practice Council, the Law Society of South Africa, etc. for the Legal Practitioner(s)
2. The following requirement under paragraph 7.2. *Definitely Not Negotiable (DNN) Requirements (Phase 2), Professional Association and Certification*, is hereby **removed**:
 - 2.1. Provide proof of a valid certificate of registration and affiliation with the relevant regulatory and professional body:
 - 2.1.1. Association of Certified Fraud Examiners (ACFE), etc. for the fraud examiner(s) and
 - 2.1.2. Legal Practice Council, the Law Society of South Africa, etc. for the Legal Practitioner(s)
3. The following schedules related to paragraph 1 and 2 above, are hereby **removed** from the RFB document, i.e.:
 - 3.1. Schedule No. 15 – *Schedule of Fraud Examiner Experience* and
 - 3.2. Schedule No. 16 – *Schedule of Legal Practitioner Experience*.
4. The following requirement under Schedule No. 22 – *Compliance Checklist of Returnable Documents, Definitely Not Negotiable (DNN) Requirements, Professional Association and Certification*, is hereby **removed**:
 - 4.1. Provide proof of a valid certificate of registration and affiliation with the relevant regulatory and professional body:
 - 4.1.1. Association of Certified Fraud Examiners (ACFE), etc. for the fraud examiner(s) and
 - 4.1.2. Legal Practice Council, the Law Society of South Africa, etc. for the Legal Practitioner(s)
